WHO Global TB Report 2022

The WHO released the Global TB Report 2022 on October 27, 2022. The Report notes the impact of the COVID-19 pandemic on the diagnosis, treatment, and burden of disease for TB all over the world. The Ministry of Health and Family Welfare has taken note of the WHO Global TB Report 2022, released on October 27, 2022, and has clarified that India has performed far better on major metrics as compared to other countries over time. India's TB incidence for the year 2021 is 210 per 100,000 population – compared to the baseline year of 2015 (incidence was 256 per lakh of population in India); there has been an 18% decline which is 7 percentage points better than the global average of 11%. These figures also place India at the 36th position in terms of incidence rates (from largest to smallest incidence numbers).
