National Health Authority (NHA) announces the successful onboarding of more than one lakh government and private healthcare facilities in the Health Facility Registry of its flagship scheme Ayushman Bharat Digital Mission (ABDM)

More than one lakh healthcare facilities across government and private sectors have been successfully onboarded in the Health Facility Registry (HFR) under the Ayushman Bharat Digital Mission (ABDM). This historic milestone paves the way for greater adoption of digital health platform and services across the country. ABDM is the flagship scheme of government being implemented by the National Health Authority (NHA). Health Facility Registry (HFR) which is being built under the ABDM is a comprehensive repository of health facilities in the country across modern and traditional systems of medicine. It includes both public and private health facilities including hospitals, clinics, diagnostic laboratories, and imaging centre.
