Hon'ble President Smt. Droupadi Murmu will virtually launch the Pradhan Mantri TB Mukht Bharat Abhiyaan on September 9th to reinvigorate the mission of TB elimination from the country by 2025. Prime Minister Shri Narendra Modi gave the clarion call to end TB in the country five years ahead of SDG target of 2030 at the Delhi End TB Summit in March 2018. The Abhiyaan will be launched in presence of Dr. Mansukh Mandaviya, Union Minister of Health and Family Welfare, Dr. Bharati Pravin Pawar, MoS (HFW), Union Ministers, Governors and Lt. Governors and other dignitaries. The virtual event will be attended by representatives from State & district health administration, corporates, industries, civil society and NGOs as the country reiterates the commitment towards TB elimination by 2025.
