#### Global Centre for Traditional Medicine at Jamnagar

The Ministry of Ayush and WHO signed a Host Country Agreement on March 25, 2022, for the establishment of the first WHO's Global Centre for Traditional Medicine in India. The salient aspects of this agreement are as follows:

- a. That WHO will set up GCTM Centre in Jamnagar (Gujarat).
- b. That it aims to support nations in developing policies & action plans to strengthen the role of traditional medicine as part of their journey to universal health coverage.
- c. The Government shall respect the functional independence of WHO in carrying out its activities and in assigning to the Centre such WHO officials or other WHO personnel as it deems necessary for carrying out the functions assigned to the Centre.
- d. The Government shall provide to WHO, free of charge, appropriate and adequate office premises for the Centre and its installations.
- e. The Government shall also be responsible for the maintenance and security of the workplace premises for the Centre, its installations, and technical plants, together with storage and archive space, meeting space, equipment and other facilities.

## Government has taken multiple steps to further increase availability of doctors in the country

As per information provided by National Medical Commission (NMC), there are 13,08,009 allopathic doctors registered with the State Medical Councils and the National Medical Commission (NMC) as on June, 2022. Assuming 80% availability of registered allopathic doctors and 5.65 lakh AYUSH doctors, the doctor-population ratio in the country is 1:834 which is better than the WHO standard of 1:1000. Also, there are 34.33 lakh registered nursing personnel and 13 lakh Allied and Healthcare Professionals in the country.

## Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA) provides a fixed day, free of cost assured, comprehensive and quality Antenatal Care

Pradhan Mantri Surakshit Matritva Abhiyan (PMSMA) provides a fixed day, free of cost assured, comprehensive and quality Antenatal Care on the 9th day of every month to pregnant women in their 2nd / 3rd trimesters of pregnancy at designated government health facilities. Under PMSMA Program, private medical practitioners are also encouraged to offer voluntary services at government health facilities. A total of 2937 volunteers are offering PMSMA services to pregnant women including poor pregnant women as well as farmer families on 9th of every month (source: PMSMA Portal). The Government honours such private medical practitioners with 'IPledgeFor9' Achievers Awards.

#### A total of 22,97,64,327 ABHA numbers have been created till 15th July 2022

Government of India launched Ayushman Bharat Digital Mission (ABDM) with an aim to establish National Digital Health ecosystem by creating an online platform, enabling interoperability of health data so as to create longitudinal electronic health record (EHR) of citizens. Three key registries of ABDM namely ABHA number/Health ID, Health Professional Registry (HPR), Health Facility Registry (HFR) and digital infrastructure for data exchange is created to enable data interoperability across digital health platforms. Creation of ABHA number is voluntary. Ayushman Bharat Health Account (ABHA) can be generated for citizens of all age-groups, post a KYC verification.

For enabling environment for ensuring the 'Health for all' the National Health Policy, 2017, envisages to provide universal access to good quality healthcare services through increasing access, increasing affordability by lowering the cost of healthcare delivery and equity. The policy envisages as its goal the attainment of the highest possible level of health and well-being for all at all ages, through a preventive and promotive healthcare orientation in all developmental policies, and universal access to good quality healthcare services without anyone having to face financial hardship as a consequence. The Policy is centered on the key principles of Equity; Affordability; Universality; Patient Centeredness & Quality of care; accountability; Inclusive partnerships; Pluralism and decentralization.

As per the latest report titled Sample Registration System (SRS) based Abridged Life Table 2015-19 published by the Office of the Registrar General & Census Commissioner, Government of India, the average life expectancy at birth has increased from 49.7 during 1970-75 to 69.7 during the year 2015-19 registering an increase of 20 years during this period.

#### **Promoting use of Generic Medicines in the Country**

the Medical Council of India, generic medicines are not being prescribed by most medical practitioners. In this regard, clause 1.5 of Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002 prescribes that every physician should prescribe drugs with generic names legibly and preferably in capital letters and he/she shall ensure that there is a rational prescription and use of drug. Further, the erstwhile Medical Council of India (MCI) had issued circulars where all the Registered Medical Practitioners have been directed to comply with the aforesaid provisions.

#### **Ayurvedic Aahar Products**

In order to recognize India's age-old principles of Ayurveda and the Aahara prepared as per ancient texts, Food Safety and Standards Authority of India (FSSAI) has formulated Food Safety and Standards (Ayurveda Aahara) Regulations, 2022 in consultation with the Ministry of Ayush and notified the regulations in the official gazette on 5th May, 2022.

#### **Diagnostic Tests for Domestic and Global Acceptance**

Ayurveda treatments are planned according to various parameters like prakriti, agni, satmya etc. of a healthy or diseased state of an individual and not solely based on diagnostic tests. Under First Schedule of Drugs and Cosmetics Act, 1940 and defined under Section 3(a) of Drugs & Cosmetics Act, 1940 and Rules there under, 59authoritative books of Ayurveda system of medicine, 31 authoritative books of Siddha system of Medicine and 14 authoritative books of Unani system of Medicines are mentioned. Government of India has the National Organ Transplant Programme (NOTP) to promote organ

donation and transplantation across the country. The provisions under the programme include financial support for:

- a. Setting up of State Organ and Tissue Transplant Organizations (SOTTOs) in each State/UT.
  - b. Setting up of National/ Regional/State Bio-material centres;
- c. Establishing new Organ Transplant/retrieval facilities and strengthening of existing Organ Transplant/retrieval facilities.
- d. Provision of Transplant Coordinators to medical colleges and trauma centres.
- e. Maintenance of deceased donor
- f. Dignified funeral of deceased donor
- g. Post-transplant immune-suppressant drugs to BPL patients.

#### Initiatives by the Government for treatment of rare diseases

The Government has launched National Policy for Rare Diseases (NPRD), 2021 in March, 2021 for the treatment of rare disease patients. The salient features of NPRD, 2021 are as under:

The rare diseases have been identified and categorized into 3 groups namely Group 1, Group 2 and Group 3.

- a. Group 1: Disorders amenable to one-time curative treatment.
- b. Group-2: Diseases requiring long term/lifelong treatment having relatively lower cost of treatment and benefit has been documented in literature and annual or more frequent surveillance is required.
- c. Group 3:- Diseases for which definitive treatment is available but challenges are to make optimal patient selection for benefit, very high cost and lifelong therapy.

The Food Safety and Standards Authority of India (FSSAI) has informed that it has recognized/notified 224 food testing laboratories (including 53 state government laboratories, 145 private laboratories and 26 other government laboratories for primary testing and 20 laboratories for testing referral food samples). FSSAI does not establish primary food testing labs but recognizes and notifies labs based on voluntary applications. Further, FSSAI is implementing a Central Sector Scheme named "Strengthening of Food Testing System in the Country including provision of Mobile Food Testing Labs (SOFTeL) under which State Food Testing Laboratories (SFTLs) are provided funds for setting up lab with basic lab equipment, installation of high end

The Ministry of Health and Family Welfare, Government of India has notified new sets of specified health warnings for all tobacco product packs by making an amendment in the Cigarettes and other Tobacco Products (Packaging and Labelling) Rules, 2008 vide GSR 592 (E) dated July 21, 2022 "The Cigarettes and other Tobacco Products (Packaging and Labelling) Third Amendment Rules, 2022". The amended Rules will be applicable w.e.f. December 1, 2022.
