Update on status of Foreign Medical Students on December 13, 2022

Foreign Medical Students/Graduates are either covered under "Screening Test Regulations, 2002" or "Foreign Medical Graduate Licentiate Regulations, 2021". There are no such provisions in the Indian Medical Council Act 1956 & the National Medical Commission Act, 2019 as well as the Regulations to accommodate or transfer medical students from any foreign medical institutes to Indian medical colleges. No permission has been given by the NMC to transfer or accommodate any foreign medical students in any Indian medical institute/university.

Update on National AIDS Control Programme on December 13, 2022

Government of India provides free lifelong antiretrovirale (ARV) medicines for people living with HIV. Under its National AIDS Control Programme, presently 15.23 lakh (Approx.) people living with HIV are given ARV medicines through 687 ART centers and 1261 link ART centers irrespective of their income background. It includes free adherence counseling, diagnostic, and monitoring services like baseline laboratory investigations, CD4 count testing, viral load testing, etc.

Mental Health Support for Students on December 13, 2022

To address the burden of mental disorders, the Government of India is supporting the implementation of the District Mental Health Programme (DMHP) under the National Mental Health Programme in 704 districts of the country for detection, management, and treatment of mental disorders/ illness with the major components of counseling in schools and colleges, workplace stress management, life skills training, suicide prevention services, and Information,

Education and Communication (IEC) activities for the generation of awareness and removal of stigma associated with Mental Illness.

The National Health Authority (NHA) has released a consultation paper on 'Operationalizing Unified Health Interface (UHI) in India' that outlines the market rules that will govern the UHI Network. UHI is envisioned as a foundational layer of the Ayushman Bharat Digital Mission (ABDM) and aims to enable interoperability in health services in India through open protocols.

The National Health Mission (NHM) envisages the achievement of universal access to equitable, affordable & quality healthcare services that are accountable and responsive to people's needs.

The main programmatic components include Health System Strengthening in rural and urban areas, Reproductive-Maternal- Neonatal-Child and Adolescent Health (RMNCH+A), and Communicable and Non-Communicable Diseases.

Indian Council of Medical Research - National Institute of Epidemiology (ICMR- NIE) conducted a mortality survey among persons older than 15 years during 2015-18 in 12 (8 North-East and 4 from the rest of the country) tribal districts which found that 66% of the total deaths were caused by non-communicable diseases (NCDs). The Union Minister of Health & Family Welfare, Dr. Mansukh Mandaviya inaugurated the Ayushmann Bharath Digital Mission (ABDM) services of AIIMS Bibinagar and witnessed the practical demonstration of real time video specialist consultation. ABDM is the initiative started by the Government to digitalize health records across the country and includes QR code-based patient registration, Health Management Information System (HMIS) a software to manage data in any Hospital including many digital services like patient registration, patient Que management, Lab information system, Doctors desk, OP Billing, etc. Dr. Mandaviya said, "with the help of the Ayushman Bharat Health Account (ABHA) card, patients can access their medical records anywhere, anytime without losing them all over India. This would enhance accessibility to their health records on the palm of their hands."
