



Software technology in India is covered under the copyright law and is not patentable.

Indian laws provide a wide array of remedies for copyright violation which include interim injunction orders, permanent injunction orders, damages, penal liability, costs of the proceedings, etc. In our experience, fate of a copyright infringement case can be determined at the preliminary injunction phase only and as counsel we provide an effective strategy paper to the client based on the understanding of the calculated choices that right holders and alleged infringers may have at each stage of litigation in order to help the client to take an informed decision as to whether and how to proceed in litigation.

#### **Protection of Plant Varieties and Farmers Rights**

India enacted the Protection of Plant Varieties and Farmer's Right Act (PPV & FR Act) in 2001 and its Rules in 2003. The Protection of Plant Varieties and Farmer's Right Authority was established in 2005. Registration of crop varieties under PPV & FR Act 2001 grants breeder an exclusive commercial right for a limited period of (15-18 years depending on the type of crop species) time and confers legal ownership on the breeder over their developed variety. Like institutional varieties, farmers' varieties can be registered in the name of farmer, a group of farmers or community and the farming community can be benefited from the commercialization of the protected varieties and benefit sharing provision in the Act. We assist our clients in obtaining plant variety registration in India.

#### **Transactional Intellectual Property Services**

For "cybersquatting" threats, Dentons Link Legal strives to alert its clients to the emergence of new generic top-level domains ("gTLD's") and country-code top level domains ("ccTLDs") so that they may be able to secure such rights in the most expedient fashion possible. Our firm is also unique in that we can alert our clients to any new domain names registered by third parties which are the same or similar to our clients' trademark or domain name rights through our Domain Name Watch Services. We also maintain our client's rights on our computer database to make certain that our client's domain name rights are properly and regularly maintained and renewed.

Furthermore, we successfully enforce our client's trademark and domain name rights not only through traditional litigation fora, but also through quasi-governmental arbitration procedures such as the Uniform Dispute Resolution Policy ("UDRP") administered by the Internet Corporation for Assigned Names and Numbers ("ICANN").
